

The 48th Annual Sandpiper Art Festival

SAG Member Artist Application 2019

On the Lake County Courthouse Lawn in Polson, Montana Saturday, August 10, 2019, 10am until 5pm

All Festival applicants pay a non-refundable \$25 application fee (\$35 after June 1). No commission on sales. A flat booth fee of \$50 will be due by July 1, 2019.

All Sandpiper Art Gallery members in good standing, who have been members for a period of at least six months prior to the Festival, may apply to have their own vendor booth at the Art Festival. If you plan to display the same kind of work you sell at the Gallery, you will be automatically accepted. Any other type of art or craft must be juried into the Festival and at least 3 images (photos or CD in JPG format) of the items must accompany your application. Sandpiper Art Gallery members may also choose to display up to five pieces of work in the SAG booth at the Festival. To apply for a booth:

- Fill out the application. Please note any special considerations you might need and we will try to accommodate you. Please let us know if your tent is high and needs extra clearance
- Submit a non-refundable application fee of \$25 (\$35 after June 1). Please note that two or more exhibitors intending to sell their work in the same space must register separately and each must pay the application fee. Only one booth fee will be required. Make checks payable to Sandpiper Art Gallery.
- Return complete application (with images of work if required) to the Gallery at PO Box 1163, Polson, MT 59860 or place the application and your application fee in the folder marked 'Festival' on the back counter in the Gallery.
- If your application requires images of your work, you may include them on a CD with your application or send them via email. Save your digital photos as JPG files and send to: festivals.sandpiperartgallery@gmail.com Include your name and show designation "Courthouse" as the subject of the email. All application and fee deadlines still apply.

Guidelines:

- Vendors must supply all materials needed for their display.
- Festival booths are 10 x 10 feet. Weights are required on tents. No stakes are allowed in the Courthouse lawn.
- No products from kits, commercially produced items, or dealers allowed.
- All food products require a food vendor application.
- Set-up times: Friday, August 9th, 5pm until 7 pm. Saturday, August 10th, 6am until 9am.
- Show hours: Saturday, August 10th, 10am until 5pm
- Returning exhibitors will be assigned to the same booth area unless a change is requested.

Sandpiper Gallery is a non-profit organization run by volunteers. The money raised during the Art Festival goes towards scholarships for students studying art and for maintenance of the gallery.
